copy annexed, adopted on July 30, 2014 by a majority vote of the Board of Directors and on September 24, 2014 by the vote of the stockholders owning or representing at least two-thirds of the outstanding capital stock, and certified under oath by the Secretary and a majority of the Board of Directors of the corporation was approved by the Commission on this date pursuant to the provision of Section 16 of the Corporation Code of the Philippines, Batas Pambansa Blg. 68, approved on May 1, 1980 and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares/club shares/membership certificates issuers or selling agents thereof. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.



AMENDED ARTICLES OF INCORPORATION

OF

LIBERTY FLOUR MILLS, INC.



KNOW ALL MEN BY THESE PRESENTS:

That we, all of whom are of legal age, citizens and residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the Philippines.

AND WE HEREBY CERTIFY THAT:

FIRST: - That the name of said corporation shall be:

LIBERTY FLOUR MILLS, INC.

SECOND: That the principal purpose for which the corporation is organized is to engage in the manufacture of flour, the utilization of its by-products and the distribution and sale of its produce.

The corporation shall have the following secondary purposes and powers:

- To issue bonds, debentures, securities, collaterals, and other obligations or otherwise incur indebtedness in such manner as may be ascertained by the corporation;
- To carry on a general import and export business dealing in goods, wares and merchandise of any kind and nature whatsoever;
- To invest in other corporations, business or enterprises within the limits allowed by law;
- To lease out equipments, machineries, or any other property including services and to otherwise dispose of them by sale, assignment, mortgage and other forms of dispositions;
- To engage in the manufacture, processing, preservation, packing and canning of foodstuffs;
- To engage or otherwise be interested in the cultivation and production of wheat.
- 7. To acquire by purchase of lease, or otherwise, lands and to own, hold, primptove, develop and manage any real estate so acquired and to erector cause to be erected on any lands owned, hold or occupied by the corporation, buildings or other structures with their appurtenances, plant crops, grow livestocks or place an other agricultural improvements on said lands to



mortgage, sell, lease or otherwise dispose of any lands or interest in lands and in buildings or other structures or agricultural improvements at any time owned or held by the corporation. (as amended on Nov. 7, 1979)

Incidental to the above powers and purposes:

- To purchase machineries, equipments, tools, materials, supplies, as may be necessary in the conduct of the business of the corporation;
- To engage the service of such workers, technicians, employees or agents as may be desired or needed in the conduct of the business of the corporation;
- To purchase, lease, or otherwise acquire such ground or building as the corporation may need in its operation;
- To enter into; make, perform and carry out contracts of every kind and nature which may be necessary or convenient for the business of the corporation;
- 5. In general, to do all and everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects or the furtherance of any of the powers herein before set forth, either alone or in connection with other corporations, firms, or individuals, and either as principals or agents, and to do every act, things, incidental or appurtenant to or growing out of or connected with the aforesaid subject, purposes or powers or any of them.

THIRD: - That the place where the principal office of the corporation is to be established or located in Liberty Building 835 A. Arnaiz Avenue, Makati City.¹

FOURTH: - That the term for which said corporation is to exist is for another fifty (50) years from and after December 26, 2008 which is the date when the original term of the corporation shall expire.
